Calvin's Old Testament Exegesis in Context Calvin in Context Jean Calvin, the reformer and pastor of Geneva, is renowned as one of the most important figures in what came to be known as the Reformed and Presbyterian branch of the Protestant Reformation. Perhaps less well known is the fact that he devoted the bulk of his creative efforts to prea- ing, lecturing, and commenting on the Bible. Calvin envisioned a program of reform in Geneva in which the Bible, properly interpreted, would shape the minds and morals of the Genevan populace. The people of Geneva, whom Calvin viewed as a precise spiritual reincarnation of the "stinecked, intractable Hebrews" of the Old Testament, were in need of some serious remedial education, and it was his duty as their chief minister to provide the requisite training in doctrine and godliness. Despite Calvin's emphasis on preaching and producing biblical cmentaries, however, scholars have often portrayed him as "a man of one 1 book"—that one book being the Institutes of the Christian Religion. In so - ing, they have produced a onedimensional and consequently incomplete view of Calvin's theological work. Scholars have tended to study Calvin's theology exclusively from the perspective of his Institutes, without taking into account his work of biblical interpretation and preaching, or the re-tionship of those efforts to the Institutes.

Delivering the Word

It professes value-neutrality and detachment from the world of politics and history. Yet, Schussler Fiorenza maintains, this posture belies an objectivity that fails to engage the sociopolitical context of both the text and today's reader. It also does not recognize the rhetorical character of biblical texts and readings. If language is understood in the sense of ancient rhetorics as a form of power that constitutes reality, then an ethics of interpretation is called for. The task of biblical studies is to identify and assess the ethical resources and moral visions of biblical religions. \"Only then,\" Schussler Fiorenza contends, \"will bibical studies be a significant partner in the global struggles seeking justice and well-being for all.\"

The Biblical Interpreter

It is ultimately the preacher who determines how the biblical text is used in the church. Richard Rohrbaugh adds a new dimension to the process of biblical interpretation by providing a cross-disciplinary study which takes into account both the interpreter and the text being interpreted. Biblical Hermeneutics

Biblical Hermeneutics is a textbook for introductory courses in hermeneutics. It takes an interdisciplinary approach that is both balanced and practical with six major areas of focus: the history of biblical interpretation, philosophical presuppositions, biblical genre, the uniqueness of Scripture, the practice of exegesis, and use of exegetical insights that will be lived and communicated in preaching and teaching. Biblical Hermeneutics is designed for students who have little or no knowledge of biblical interpretation. It provides, in one volume, resources for gaining a working knowledge of the multi-faceted nature of biblical interpretation and for supporting the practice of exegesis on the part of the student. The first chapter \"A Student's Primer for Exegesis\" by Bruce Corley gives the student a bird's eve view of the entire process. It becomes for the student a kind of template to which they will return again and again as they engage in the process of exegesis. This revised edition of Biblical Hermeneutics contains seven new chapter that deal with the major literary genre of Scripture: law, narrative, poetry, wisdom, prophecy, Gospels and Acts, epistles, and apocalyptic. The unique nature of Scripture is presented in part three that addresses the authority, inspiration, and language of Scripture. The book contains two extensive appendices, \"A Student's Glossary for Biblical Studies\" and an updated and expanded version of \"A Student's Guide to Reference Books and Biblical Commentaries.

Evangelical Hermeneutics
