The COVID-19 pandemic (also known as the coronavirus pandemic and COVID pandemic), caused by severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2), began with an outbreak of COVID-19 in Wuhan, China, in December 2019. Soon after, it spread to other areas of Asia, and then worldwide in early 2020. The World Health Organization (WHO) declared the outbreak a public health emergency of international concern (PHEIC) on 30 January 2020, and assessed the outbreak as having become a pandemic on 11 March.

require that hedge funds be marketed only to institutional investors and high-net-worth individuals.

A small modular reactor (SMR) is a type of nuclear fission reactor with a rated electrical power of 300 MWe or less. SMRs are designed to be factory-fabricated and transported to the installation site as prefabricated modules, allowing for streamlined construction, enhanced scalability, and potential integration into multi-unit configurations. The term SMR refers to the size, capacity and modular construction approach. Reactor technology and nuclear

processes may vary significantly among designs. Among current SMR designs under development, pressurized water reactors (PWRs) represent the most prevalent technology. However, SMR concepts encompass various reactor types including generation IV, thermal-neutron reactors, fast-neutron reactors, molten salt, and gas-cooled reactor models.
